RESOLUTION NO. 219282

WHEREAS, the California State Architect has contacted the various cities, counties and other local jurisdictions in the State of California regarding the development of a statewide standard design for curb ramps to serve disabled persons; and

WHEREAS, it is recognized that there are many unique classes of disabled persons with diverse mobility needs, including wheelchair users, the blind, the elderly and other disabled persons; and

WHEREAS, it is important to provide a design that will service not only the needs of the disabled but the needs of all sidewalk users as well; and

WHEREAS, for over two years, The City of San Diego has worked with citizens' advisory committees including wheelchair users, the blind, the partly-sighted, the elderly and other disabled persons; and

WHEREAS, these citizens' advisory committees have developed and tested a design that successfully meets the needs of all users; and

WHEREAS, more than 900 ramps of this design have been successfully constructed and used in the City without any significant problem; and

WHEREAS, this design has received the unanimous approval of the Committee for the Removal of Architectural Barriers and the
