BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$493,715.25 by Griffith Company, a corporation, for the IMPROVEMENT OF IMPERIAL AVENUE FROM 47TH STREET TO 400 FEET EAST OF EUCLID AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759422.
2. That the expenditure of \$175,483.00 is hereby authorized out of the Gas Tax Fund, Fund No. 220, that the expenditure of \$426,000.00 is hereby authorized out of the Capital Outlay Fund, Fund No. 245 of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF IMPERIAL AVENUE FROM 47TH STREET TO 400 FEET EAST OF EUCLID AVENUE in the City of San Diego, and related costs.
