That the City Manager is hereby authorized and empowered to do by City Forces all the work of Relocating Existing Facilities as required in connection with IMPROVEMENT OF IMPERIAL AVENUE FROM 47TH STREET TO 400 FEET EAST OF EUCLID AVENUE, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$13,796.00.
