BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$281,753 by VALLEY CREST LANDSCAPE, INC., a corporation, for the CONSTRUCTION OF SOUTHEAST SAN DIEGO SPORTS FIELD-PHASE III, in the City of San Diego, California, is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759756.
2. That the expenditure of \$194,500 is hereby authorized out of the Capital Outlay Fund (Fund 245) and \$160,000 from 1977 Community Development Block Grant Funds (Fund 2930) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF SOUTHEAST SAN DIEGO SPORTS FIELD-PHASE III, in the City of San Diego and related costs.
