1. 2. That the expenditure of \$75,000 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF CITY ADMINISTRATION BUILDING FIRE SAFETY IMPROVEMENTS in the City of San Diego and related costs.
