BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the Transient Occupancy Tax Fund 223 the sum of \$5,000 from the Contingency Reserve (52.29) to South Bay Economic Development Corporation (52.60) to be used solely and exclusively for the above purpose.
