

RESOLUTION No. 219319 (R-78-499)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of DANIEL L. DUDAS, as Trustee under Declaration of Trust dated December 20, 1973, executed in favor of the City of San Diego, bearing date of August 9, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across that portion of Block 13 of The Muirlands, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 2024, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named INSPIRATION DRIVE.


