


RESOLUTION No. 219327 (R-78-455)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$11,437.50 by R. E. Hazard Contracting Company, a corporation, for the IMPROVEMENT OF GOLD COAST DRIVE BETWEEN WESTCHESTER AVENUE AND BLACK MOUNTAIN ROAD in the City of San Diego, California is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760287.
2. That the expenditure of \$17,200 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF GOLD COAST DRIVE BETWEEN WESTCHESTER AVENUE AND BLACK MOUNTAIN ROAD, in the City of San Diego and related costs.
