

RESOLUTION No. 219332

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SAMUEL S. VENER, MARY VENER and LOUIS E. VENER, executed in favor of the City of San Diego, bearing date of August 11, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, through, over, under, along and across that portion of the northeast one quarter of the northeast one quarter of Section 35, Township 18 South, Range 2 West, S.B.M. in the City of San Diego, County of San Diego, State of California, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcels A & D, is hereby dedicated as and for a public street, and the same is hereby named VIA DE LA MELODIA; and the land therein conveyed as Parcel B is hereby dedicated as and for a public street, and the same is hereby named SMYTHE AVENUE; and the land therein conveyed as Parcel C is hereby dedicated as and for a public street, and the same is hereby named VIA DE LA BANDOLA.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the San Diego County Recorder.
