That the City Manager be, and he is hereby authorized and directed to execute, for and on behalf of The City of San Diego, an amendment to the subdivision agreement for OCEAN BLUFFS RESUBDIVISION, to provide for the substitution of WILSHIRE DIVERSIFIED, INC., a California corporation, and CALIFORNIA COMMUNITIES, INC., a California corporation, for MCKEON CONSTRUCTION COMPANY, a California corporation, as subdividers, under the terms and conditions set forth in the form of Amendment to Subdivision Improvement Agreement for OCEAN BLUFFS RESUBDIVISION, on file in the office of the City Clerk as Document No. 761231.

BE IT FURTHER RESOLVED, that Bond No. 5018351, issued by the HARTFORD ACCIDENT AND INDEMNITY COMPANY in the sum of \$53,311.00 is hereby accepted as improvement security for the performance of the public improvements, and that bond No. 143734, issued by the ARGONAUT INSURANCE COMPANY, in the sum of \$52,311.00, is hereby released.
