BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the acceptance by the City Manager of that deed of SADA O HORIYE, a single man, executed in favor of the City of San Diego, bearing date of August 29, 1977, conveying to said City fee title for street purposes, drainage and slope easements affecting all those portions of Lots 14 and 15 of Cave and McHatton Subdivision, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 159 filed in the office of the County Recorder of San Diego County, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1, is hereby dedicated as and for a public street, and the same is hereby named SKYLINE DRIVE; and the land therein conveyed as Parcel 2 and 3, is hereby dedicated as and for a public street, and the same is hereby named 61st STREET.

That the expenditure of not to exceed \$3,000.00 from Gas Tax Fund 220 for said property, is hereby authorized.

That the City Clerk after acceptance by the City Manager, is hereby authorized and directed to deliver said deed along with a certified copy of this resolution to the Property Director for further handling.
