

RESOLUTION No. 219350 (R. 78-429)

Adopted on SEP 21 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

BARRIOS, husband and wife, as joint tenants, as to an undivided one-half interest; JOSE G. and CELIA G. 
