
Adopted on SEP 21 1977

That the acceptance by the City Manager of those deeds of VISTA SERENA, INC., a California corporation and PATRICK and ALICE BARAJAS, husband and wife, as joint tenants, executed in favor of the City of San Diego, bearing dates of July 28, 1977 and July 27, 1977, conveying to said City the permanent easement and right of way for a public alley and incidents thereto, over, under, upon, along and across all those portions of Lots 1, 2, 3, 4, 5 and 6 of Block 13, Nordica Heights Unit No. 2, according to Map thereof No. 1455, all as more particularly described in said deeds, be, and the same is hereby approved.
