BE IT FURTHER RESOLVED, that the expenditure of \$17,000 is hereby authorized from Capital Outlay Fund 245, solely and exclusively for the purpose of providing funds for the above described services.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$7,800 from Resolution No. 215664 (C.I.P. #23-672) to C.I.P. #23-672.1.
