
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to amend the Fourth Amendment to the current Memorandum of Understanding between the San Diego Regional Employment and Training Consortium (RETC) and the City of San Diego, governing the City's participation as a Title II Program Agent under the Comprehensive Employment and Training Act (CETA) of 1973, as amended, to reduce the funds available by \$51,070.00 from \$9,516,214.00 to \$9,465,144.00.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City a contract with R.E.T.C. governing the City's participation as a CETA Title II Program Agent and accepting an additional allocation of \$6,515,425.00 to continue the City and City Subagent program through September 30, 1978 under the terms and conditions set forth in the form of agreement on file in the

office of the City Clerk as Document No. 761269.
