BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to amend the First Modification to the current Contract between the San Diego Regional Employment and Training Consortium (RETC) and the City of San Diego, governing the City's participation as a Title VI Program Agent under the Comprehensive Employment and Training Act (CETA) of 1973, as amended, to reduce the contract amount by \$47,249.00 from \$9,493,004.00 to \$9,445,755.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City a Second Modification to the Contract with RETC to accept an additional allocation of \$17,488,809.00 to continue the City and City Subagent programs through September 30, 1978, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 761270.
