

1. That the sole bid of \$298,000.00 by Riha Construction Co., a corporation for the CONSTRUCTION OF EQUIPMENT REPAIR FACILITY ADDITION AT ROSE CANYON OPERATIONS STATION in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760361.
2. That the expenditure of \$368,300.00 is hereby authorized out of the Capital Outlay Fund (Fund No. 245), and that the expenditure of \$11,700.00 is hereby authorized out of the Capital Outlay Fund (Fund No. 245) Unallocated Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF EQUIPMENT REPAIR FACILITY ADDITION AT ROSE CANYON OPERATIONS STATION in the City of San Diego, and related costs.




