WHEREAS, the United States Department of Commerce Office of Minority Business Enterprise (OMBE) has agreed to provide funds in the amount of \$25,000 to be used in a program to increase the number of minority vendors doing business with the City of San Diego pursuant to the OMBE Matching Grant Assistance Program; and

WHEREAS, The City of San Diego is desirous and willing to participate in said program to assist potential vendors, NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

That the City Manager be and he is hereby authorized to execute and submit, for and on behalf of said City, to the U.S. Department of Commerce OMBE an application/grant award in the amount of \$25,000 to be used to assist minority vendors doing business with the City of San Diego pursuant to the Matching Grant Program.

2) That the City of San Diego agrees to provide required matching funds or in-lieu services for said program as may be required.

3) That grant funds offered by OMBE are hereby accepted and the City Manager is authorized without further Council Action, but subject to Council policy to go to bid (when necessary) and to execute contracts for consultant
