

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute and file, for and on behalf of said City, an application for a federal grant in the amount of \$2,657,000 on behalf of the San Diego Transit Corporation with the Urban Mass Transportation Administration (UMTA), U. S. Department of Transportation, to obtain federal participation in the purchase of nineteen (19) standard size buses, ten (10) automobiles, a computer and associated computer hardware, and for implementation of the federally mandated project F.A.R.E. and for miscellaneous administrative costs incurred in performance of the grant contract, under the terms and conditions set forth in that form of application on file in the office of the City Clerk as Document No. 761206.

BE IT FURTHER RESOLVED, that the City Manager is authorized to execute and file with such application an assurance of any other document required by the U. S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964.
