BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$170,581 by Metro-Young Construction Co., A Division of Olson Construction Co., a corporation, for CONSTRUCTION OF THE CATALINA PUMP STATION, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760003.
2. That the expenditure of \$227,181 is hereby authorized out of Water Revenue Fund 502 of the City of San Diego solely and exclusively for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$7,181 within Water Revenue Fund 502 from the Unallocated Reserve (69.79) to Water Construction Outlay (63.19)
