HOPE CEMETERY SPRINKLER SYSTEM in the City of San Diego, California, is hereby accepted; and that the City Manager is hereby authorized to execute a contract including Addendum A therefor in accordance with the form on file in the office of the City Clerk as Document No. 760360.
2. That the expenditure of \$142,000 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF MT. HOPE CEMETERY SPRINKLER SYSTEM in the City of San Diego and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$128,000 from CIP No. 38-011 to Capital Outlay Reserve CIP No. 90-245.
