Farrell, Inc., a corporation for the CONSTRUCTION OF PRESIDIO PARK - WATER SERVICE FOR FIRE FIGHTING, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760288.
2. That the expenditure of \$25,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245), that the expenditure of \$2,100.00 is hereby authorized out of the Capital Outlay Unallocated Reserve Fund (CIP 90-245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF PRESIDIO PARK - WATER SERVICE FOR FIRE FIGHTING, in the City of San Diego, and related costs.
