
Adopted on OCT 5 1977

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BEMENT-DAINWOOD-STURGEON, CIVIL ENGINEERS, INC., for professional services for design of traffic signals and safety lighting systems at the intersections of CLAIREMONT MESA BOULEVARD and LIMERICK STREET, GRAND AVENUE and MISSION BOULEVARD and ARDATH LANE and ARDATH ROAD, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 761452.

BE IT FURTHER RESOLVED, that the expenditure of \$13,000 and \$2,000 is hereby authorized out of Gas Tax Fund 220 and Capital Outlay Fund 245, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
