

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a FIRST AMENDMENT TO AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND NESTE, BRUDIN & STONE INCORPORATED to increase the maximum compensation for engineering services to \$117,038.32 in connection with the preparation of an Operation and Maintenance Manual for the Point Loma Waste Water Treatment Plant and Sewage Pump Stations 1 and 2, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 761456.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within Sewer Revenue Fund 506 the sum of \$20,000 from the Unallocated Reserve (69.97) to Sewer C.I.P. (46-002) City Force Engineering (69.42), and that the expenditure of said sum is hereby authorized for the sole and exclusive purpose of providing funds for the above project and other related engineering costs.
