BE IT FURTHER RESOLVED, that the request contained in said Change Order No. 1 for an extension of time of 40 days, to wit, to and including April 26, 1978, in which to complete said contract be and the same is hereby approved and the time of completion under said contract is hereby extended to April 26, 1978.
