

RESOLUTION No. 219450 (R78-636)

Adopted on OCT 5 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$381,000 is hereby authorized out of Storm Drain and Flood Control Bond Fund 727 of The City of San Diego and the expenditure of \$2,285,188 from Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of acquiring fee title and easements in Acre Lot 12 and portions of Acre Lot 11, Blocks 25, 26, 27, 28, 29, 30, 31, 32, 33 and 34, and that Certain Unnumbered Block lying East of Block 34 and South of Block 26, in Tia Juana City, according to Map thereof No. 562 and portions of Sections 1, 2, 3, and 11, Township 19 South, Range 2 West, San Bernardino Base and Meridian, and portions of Lot 35, Township 18 South, Range 2 West, San Bernardino Base and Meridian, according to Official Plat thereof, in the City of San Diego, County of San Diego, State of California, required by the City for the Tia Juana River Flood Control Project.
