WHEREAS, local coastal program regulations pursuant to the 1976 California Coastal Act require the submittal by local governments to the coastal commissions of issues identification prior to submittal of the local coastal program (Section 00022); and

WHEREAS, the local coastal program regulations provide for a preliminary review of proposed local coastal programs (Section 00061); and

WHEREAS, the Planning Department has prepared the draft Otay Mesa-Nestor Community Plan, the Otay Mesa-Nestor Issues Identification Report and the Mission Bay Issues Identification Report, and the Park and Recreation Department has prepared the Preliminary Mission Bay Master Plan; and

WHEREAS, it is appropriate to insure that the above mentioned plans adequately address the issues identified in the Issues Reports; and

WHEREAS, there has been adequate informal staff review of the above mentioned documents between the staffs of the Planning Department and the San Diego Coast Regional Commission; and

WHEREAS, the Planning Department has submitted the above mentioned documents to the City Council Rules Committee for consideration, and the Rules Committee has reviewed this material and found it appropriate with respect to implementing the Coastal Act; NOW, THEREFORE,


