WHEREAS, for several months representatives of the San Diego Police Department have been meeting with representatives of the County's Fiscal and Justice Agency, San Diego County Sheriff's office, and the Community Services Agency for the purpose of considering consolidation of the Police and Sheriff's Crime Laboratories into a Regional Laboratory Facility; and

WHEREAS, the aforementioned meetings and discussion have identified numerous advantages for both the city and county law enforcement agencies if such consolidation were to occur; and

WHEREAS, the Council for The City of San Diego endorses the concept of consolidation of the crime laboratories of the San Diego Police Department and the San Diego County Sheriff; and

WHEREAS, the Council believes the best possible location for the laboratory is near downtown San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby endorses the concept of consolidation of the crime laboratories of the San Diego Police Department and the San Diego County Sheriff.

BE IT FURTHER RESOLVED, that the Council expresses a preference for a central location near downtown San Diego for the consolidated facility.
