BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$123,481.00 by David G. Evans, an individual dba Evans Construction Company, for the REMOVAL OF ARCHITECTURAL BARRIERS - CITY ADMINISTRATION BUILDING AND CITY OPERATIONS BUILDING in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760161.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$20,000.00 from Third Year Block Grant Fund 2930 to reimburse the 100 Fund Unallocated Reserve.
3. That the expenditures of \$166,570.00 from Third Year Block Grant Fund 2930 and \$8,430.00 from Capital Outlay Fund 245 of the City of San Diego are hereby authorized solely and exclusively for providing funds for said project and related costs.
