WHEREAS, The City of San Diego is the owner of one 1969 MODEL 260 SERIES A 20-YARD MOTOR SCRAPER and one 1970 MODEL 260 SERIES A MOTOR SCRAPER; and

WHEREAS, said motor scrapers are no longer needed for City purposes and the City Manager has recommended that the same be sold; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Purchasing Agent of said City be and he is hereby authorized and directed to sell the above-mentioned motor scrapers.
2. That all expenses in connection with the sale of one 1969 MODEL 260 SERIES A 20-YARD MOTOR SCRAPER and one 1970 MODEL 260 SERIES A MOTOR SCRAPER shall be deducted from the proceeds received from the sale thereof.
3. That a payment of up to 10% of the sales price is hereby authorized for actioneering services in connection with the sale of the 1970 MODEL 260 SERIES A MOTOR SCRAPER.
