BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with MOHLE, PERRY & ASSOCIATES, INC. for professional engineering services for design of traffic signal and safety lighting systems at the intersections of EL CAJON BOULEVARD and TEXAS STREET, EUCLID AVENUE and FEDERAL BOULEVARD, LAKE MURRAY BOULEVARD and NAVAJO ROAD, and 25TH STREET and MARKET STREET, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 761534.

BE IT FURTHER RESOLVED, that the expenditure of \$10,000 and \$7,000 is hereby authorized from Gas Tax Funds and Capital Outlay Funds 245, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
