WHEREAS, The City of San Diego has been informed of significant pending increases in fire insurance rates for commercial properties in the City which are used to calculate premium charges for policies issued within the City; and

WHEREAS, the City has unsuccessfully sought from the Insurance Service Office (ISO) organization-compiled source data supporting these commercial rate revisions; and

WHEREAS, the San Diego Fire Department is concerned about the source and validity of the ISO data but is unable to properly evaluate the information due to an inability to obtain the material needed; and

WHEREAS, access to said data will enable the San Diego Fire Department to better manage efficient fire protection operations and best protect the health and safety of our citizens; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager or his designated representative is hereby directed by this Council and he is so authorized to request of the Commissioner of the California Department of Insurance that certain specific loss data and premium information pertaining to commercial fire rate revisions be provided
