BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Public Resources Code, Section 21081, the following findings are made with respect to the environmental impacts identified in Environmental Impact Report No. 77-01-29:

The construction of a solid wall has been incorporated into project plans by the developer to mitigate traffic noise impacts to an insignificant level. Mitigation of air quality and energy conservation impacts is not within the control of the developer or the City, and no feasible project alternative exists which would significantly alter the nature of the air and energy impacts. Revegetation with drought-resistant plant species would reduce the need for permanent slope irrigation and reduce the water conservation impact to insignificance. This measure should be made a condition to tentative map approval.
