as follows:


That Council Policy 000-10 regarding use of the Council

Subject	POLICY NUMBER
USE OF THE COUNCIL CHAMBER, CONFERENCE ROOM AND ROOM 2000	000-10

BACKGROUND

When the Chamber or Council Conference Room or Room 2000 was not in use or reserved for the City Council, other City commissions, boards and committees, other government bodies, citizen councils, etc., have made regular or occasional use of these facilities.

PURPOSE

To establish a policy and procedure for the use of these facilities.

POLICY

1. Only official or quasi-official governmental bodies may use these facilities. Community organizations such as town councils may use these facilities if the purpose of their meeting is directly related to official City business and the meeting will include participation by City officials.
2. The City Council shall have first priority for use of these facilities.
3. The City Clerk shall schedule and administer the use of these facilities.


