BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Public Resources Code, Section 21081, the following findings are made with respect to the environmental impacts identified in the Fourth Amendment to Environmental Impact Report No. 75-06-21P:

The single significant environmental effect involves the overall development's contribution to cumulative increases in air pollution generation. Within the scope of the project, there is no feasible mitigation which would significantly alter the nature or magnitude of this impact.

Construction and occupancy of the project will not in itself generate any significant quantity of air pollution. However, the vehicles used by the occupants will contribute to a significant regional air quality problem, but their contribution will be so small that no measurable degradation of air quality will occur. In any case, air pollution from stationary sources is under the control of the County Air Pollution Control District, and pollution from vehicles is controlled by the State Air Resources Board and the Federal Environmental Protection Agency. Thus, existing non-City regulations, if fully implemented, should control vehicular-caused air pollution. Furthermore, control of regional air quality is totally beyond the scope of this residential project.
