WHEREAS, the Federal Resource Conservation and Recovery
Act of 1976 (Public Law 94-580) requires that the Governor of
each state, after consultation with local elected officials,
shall promulgate regulations identifying the boundaries of each
area within the state which are appropriate for carrying out
regional solid waste management; and

WHEREAS, the State Solid Waste Management Board proposes to designate, among others, the San Diego Areawide 208 Planning Area as a Solid Waste Management Planning Region; and

WHEREAS, existing state law declares that it is the intent of the legislature that primary responsibility for adequate solid waste management and planning shall rest with local government; and

WHEREAS, the state law presently requires counties to prepare solid waste management plans for all waste disposal within the County; and

WHEREAS, there is no direct relationship between the policy-making, public information, budgeting, planning and legal function of solid waste management and the boundaries of the San Diego Areawide 208 Planning Area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that this Council declares itself to be opposed to the designation of the San Diego Areawide 208 Planning Area as a Solid Waste Management
