WHEREAS, the Council has pursued a policy of conducting public hearings in respect to Annual Programming for the purpose of defining citywide goals and objectives, developing program content and funding, reviewing program effectiveness and prioritizing community needs for the Fiscal Year 1979 Budget; and

WHEREAS, the objective of such hearings is to provide citizens an opportunity to provide input and assist in these specified tasks; and

WHEREAS, the Council recognizes that many citizens cannot adjust their schedules so as to attend public meetings during those hours normally scheduled for work; and

BE IT RESOLVED, by the Council of The City of San Diego, that a Special Council Meeting be scheduled on November 9, 1977, at 7 p.m., in the Council Chambers of the City Administration Building for the purpose of providing citizens an opportunity to provide input and thereby assist the Council in the matter of Annual Council Programming for the purpose of defining citywide goals and objectives, developing program content and funding, reviewing program effectiveness, and prioritizing community needs for Fiscal Year 1979 Budget.
