HAZARD CONTRACTING CO., a corporation, for the IMPROVEMENT OF SOUTH SAN DIEGO INDUSTRIAL PARK - UNIT NO. 1 - (COMMUNITY DEVELOPMENT BLOCK GRANT PROJECT), in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760028.
