FOSTER CONSTRUCTION CO. for THE REMOVAL OF ARCHITECTURAL BARRIERS - GUTTER AND PAVEMENT REPLACEMENT - CONTRACT 6, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760498.
2. That the expenditure of \$47,600.00 is hereby authorized out of the Second Year Block Grant Fund 290 and that the expenditure of \$2,400.00 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
