Said Council hereby finds that that certain map surveyed
by DAVID L. WALDEN, a Registered Civil Engineer, entitled
"RIO DEL SUR-UNIT NO. 2 Being a subdivision of a portion of
the Northeast Quarter of the Southwest Quarter of Section 35,
Township 18 South, Range 2 West, San Bernardino Meridian, in
the City of San Diego, County of San Diego, State of California,
according to Official Plat thereof, together with a portion
of Vista Lane as dedicated to public use.", is made in the
manner and form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown thereon
is hereby approved and accepted; and said Council hereby accepts
on behalf of the public, the following: Via Encantadoras for
public purposes; and said street is hereby declared to be a
public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation, the
easement with the right of ingress and egress for the ~~construction~~


