
Adopted on OCT 19 1977

That the acceptance by the City Manager of that Tax Deed of JAMES E. JONES, Tax Collector of the County of San Diego, State of California, executed in favor of the City of San Diego, bearing date of August 30, 1977, granting to said City that property known as Rancho de la Nacion, located southwesterly of the intersection of Reo Drive and Altamont Drive in the Paradise Hills area, as more particularly described in said Tax Deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named REO DRIVE.
