


RESOLUTION No. 219527 (R-78-644)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GIRLS CLUB OF SAN DIEGO, INC., a nonprofit corporation, to reconstruct the club house structure at 606 South 30th Street, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 761589.

BE IT FURTHER RESOLVED, that the expenditure of \$49,000 is hereby authorized out of Community Development Block Grant Fund 2930, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced project and related costs.
