

RESOLUTION No. 219533, (R-78-609)

Adopted on OCT 19 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the proposal of Advance Planning and Research Association to establish five community recycling centers on City-owned property, which centers will be operated by existing non-profit organizations, is hereby approved in concept.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to negotiate an appropriate agreement with Advance Planning and Research Association, whereby the latter will be paid a total of not to exceed \$12,600, for services rendered in establishing the centers during a six-month period, and for providing management services for such centers for the six-month period, subsequent to their establishment.
