That Change Order No. 1, dated August 24, 1977, heretofore filed with the City Clerk of said City as Document No. 761600, issued in connection with the contract between The City of San Diego and W. Daniel Larsen for the CONSTRUCTION OF MISSION BAY PARK BIKEWAY, MIDDLE JETTY, said contract having been filed in the office of the City Clerk as Document No. 756583, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$30,000 and an extension of time of 300 days extending the completion date to November 11, 1977, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$30,000 be hereby authorized out of Bicycle Land State Grant Fund 2720 of The City of San Diego, solely and exclusively, for the purpose of providing funds for the above project, supplementing Resolution No. 216604 in this amount.
