WHEREAS, by Resolution No. 218415 adopted on May 18, 1977, the City Council granted an individual owner/operator Certificate of Public Convenience and Necessity to operate a taxicab to Raymond A. Keeler; and

WHEREAS, Raymond A. Keeler failed to comply with the provisions of said resolution which required him to commence operation of his taxicab within ninety (90) days of the adoption of said resolution; and

WHEREAS, said resolution provided that in the event any certificate holder failed to commence operation of his taxicab within ninety (90) days of the adoption of the resolution the City Manager was directed to recommend the revocation of the certificate and to present to this City Council the next prospective individual owner/operator applicant as determined by the date of filing an application; and

WHEREAS, Thomas Claybrook Hood, listed on the City Manager's Report, a copy of which has been filed with the City Clerk as Document No. 759365, has applied to the City Council for a Certificate of Public Convenience and Necessity to operate a taxicab within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.0101(d) of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has filed his written report with this Council as Document No. 759365; and

WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE, -

BE IT RESOLVED, by the Council of The City of San Diego, as follows;

That Thomas Claybrook Hood, having filed an application for a Certificate of Public Convenience and Necessity to operate a taxicab pursuant to the provisions of Section 72.0101(b) of the San Diego Municipal Code, and the City Manager having conducted the required investigation, the City Council hereby grants a Certificate of Public Convenience and Necessity to Thomas Claybrook Hood to operate a taxicab, subject to compliance with all provisions of the San Diego Municipal Code.

BE IT FURTHER RESOLVED, that pursuant to this resolution in the event the certificate holder named herein fails to pay the business license fees called for under Municipal Code Section 31.0344 and in the manner provided in Section 31.0104 within twenty (20) days of the adoption of this resolution and commence operation of his taxicab for which the certificate is now issued within ninety (90) days of the adoption of this resolution, ~~the~~ City Manager be and he is hereby directed to recommend the revocation of the certificate and to present to this City Council the next prospective individual owner/operator applicant as determined by the date of filing an application.




