WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations-as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Ascencion Reyes	Property	\$ 30	Mr. Reyes is a Gardener at the San Diego Stadium. He suggested an easier method of moving the portable stands from the visitors' dugout when converting the field from baseball to football. This saves \$300 annually and prevents damage to the turf.
Leroy Murphy	Engineering and Development	\$ 25	Mr. Murphy is a Senior Engineering Aide in Engineering and Development. He suggested that Park and Recreation be provided with microfilm duplicates on all Park facilities. This reduces the number of person hours and mileage required to research these records in Engineering and Development. First year savings are estimated to be \$250.
John T. Mulvey	Personnel	\$ 15	Mr. Mulvey is a Junior Clerk in the Personnel Pool. He suggested that electrical cords be placed beneath chair protectors to prevent personnel from tripping over them. This is a safety improvement, and proved to be significant in preventing falls in one City department.
