

RESOLUTION NO. 219554Adopted on OCT 26 1977

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Mary F. Labiak	Park and Recreation	\$ 50	Ms. Labiak is an Intermediate Typist in the Park Division. She suggested that the Municipal Code sections referring to street trees be revised to reflect the responsibility of property owners. This has been done and is considered to be a significant solution to a problem with broad application.
Richard J. Bono	Fire	\$ 50	Mr. Bono is a Fire Fighter. Long before the water shortage became widely publicized, he suggested that water restrictors be placed in shower heads at Fire Stations. This saves \$500 annually in water and the energy to heat the water.
Kenneth R. Wise	Transportation	\$ 40	One year ago Mr. Wise suggested that encoders and decoders be replaced with substitution cards made by City forces. This has saved a total of \$4,242. This is the remainder of Mr. Wise's award.
Ascencion Reyes	Property	\$ 35	Mr. Reyes is a Gardener at San Diego Stadium. He suggested that the wheels of the batting cage be welded in a straight position to make it easier to move off the field. This was done, and it now takes one person to move the cage, rather than three. Savings is \$350 annually.
