Timothy L. O'Connell	Planning	\$ 10	Mr. O'Connell is an Assistant Planner. He suggested that the City provide depositories at City landfills for the recovery of used motor oil. Although it was Mr. O'Connell's suggestion to have the City run the operation, it was decided to allow the Ecology Center to operate the program. This was felt to be a significant conservation idea.
Flavian R. Geis	Engineering and Development	\$ 10	Mr. Geis is an Intermediate Typist. He suggested that a multi-part form used by both City employees and the public be printed in a one-part form for the use of City employees only. Citizens will continue to use the multi-part form. This saves the City approximately \$100 annually.
