BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of a. MOTOROLA, INC., b. GENERAL ELECTRIC COMPANY, c. RCA CORPORATION, d. FEDERAL SIGNAL CORPORATION, e. PACIFIC COMMUNICATIONS, f. SINCLAIR RADIO LABORATORIES, INC., and g. MICROWAVE ASSOCIATES, INC., are hereby accepted, and the City Manager is hereby authorized to execute contracts for furnishing COMMUNICATIONS EQUIPMENT AS follows:

- a. MOTOROLA, INC., for Items 1, 2, 3, 4, 8, 10, 12, 14, and 15, including all options, as may be required, for a period of twelve (12) months from the date the initial purchase order is issued. Terms net 30 days, plus sales tax.
- b. GENERAL ELECTRIC COMPANY for Items 5, 7, 11, 18, and 20, including all options, as may be required, for a period of twelve (12) months from the initial purchase order is issued. Terms net 30 days, plus sales tax.
- c. RCA CORPORATION for Item 6, including all options, as may be required, for a period of twelve (12) months from the date the initial purchase order is issued. Terms net 30 days, plus sales tax.
- d. FEDERAL SIGNAL CORPORATION for Item 9, including all options, as may be required, for a period of twelve (12) months from the date the initial purchase order is issued. Terms net 30 days, plus sales tax.
- e. PACIFIC COMMUNICATIONS for Item 13, including all options, as may be required, for a period of twelve (12) months from the date the initial purchase is issued. Term net 30 days, plus sales tax.
- f. SINCLAIR RADIO LABORATORIES, INC. for Items 16 and 19, as may be required, for a period of twelve (12) months from the date the initial purchase order is issued. Terms net 30 days, plus sales tax.
- g. MICROWAVE ASSOCIATES, INC. for Item 17, as may be required, for a period of twelve (12) months from the date the initial purchase order is issued. Terms net 30 days, plus sales tax.
