

That the bid of VALLEY MOTORCYCLE SALES, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of THIRTEEN (13) POLICE MOTORCYCLES (HONDA CB750A) at a cost of \$3,277.00 each for a total cost of \$42,601.00; terms net 30 days, plus sales tax less trade in of three (3) 1973 Harley Davidson Police Motorcycles for \$1500 each and ten (10) 1974 Harley Davidson Police Motorcycles for \$1600 each with an option to purchase up to seven (7) additional motorcycles at the same price and terms by December 1, 1977.
